## SERVICES

Our Listing Services team will provide guidance on all stages of the listing process from initial review to final listing and will advise issuers of their ongoing listing requirements.

Our services include:

- Assessing the issuer's suitability to have their securities listed on the relevant stock exchange.
- Advising on the relevant disclosure requirements which must be made in the listing particulars / prospectus (offering document) to be used for the listing, taking into account the stock exchange on which the securities are seeking an admission to listing.
- Drafting of ancillary documentation to accompany listing applications and liaising with the service providers of the issuer to gather all the ancillary documents for achieving the listing.
- Submitting the formal listing application to the relevant stock exchange.
- Advising on any comments raised by the relevant stock exchange (or regulator, if applicable) during the application process and liaising with the relevant stock exchange (or regulator, if applicable) and the issuer's service providers to resolve those comments.
- Advising on the ongoing obligations associated with maintaining a stock exchange listing, taking into account any relevant European directives which may be applicable.
- Applying to Euronext Dublin for ISIN, FISN and CFI codes for Irish domiciled issuers.
- Applying to Euronext Dublin for Legal Entity Identifier (LEI) codes for issuers (not limited to Irish domiciled issuers).
- Applying to the London Stock Exchange for ISIN, FISN and CFI codes for securities not clearing through a central depository system.
